CLERK'S REPORT:

Motion (**Keller/Pollack**) to approve Resolution to Establish Municipal Wards for Voting Purposes.

Motion (**Frassetto/Pollack**) to approve City of Oshkosh Ambulance Service Agreement with potential conditions to revisit based off of state reimbursement rates for 2021- 2023 state budget. Deputy Clerk Coppola provided update on ARPA Reporting to include new date of April 30, 2022 as due date for first project expenditure to cover period between award date to March 31, 2022. Also provided update on TDS service map coverage for 2022- Pollack shared communication with Spectrum regarding map coordinates, so a request is made to follow up with TDS for exact coordinates of service for VSP map. Also provided update on Van Dyne Fire Department invoice split cost due for November 26, 2021.

PUBLIC PARTICIPATION

Tricia Rathermel of GO EDC offered information regarding a broadband study that New North is offering to 18 counties with direct partnership with Winnebago County. All homes are being surveyed in the region. Upon review, maps will be provided to County so MSA and Design 9 can utilize the information to ensure services are offered at all socioeconomic levels to ensure service can reach all who may need it. This effort is to improve broadband in rural areas that are
