

Instructions to Access/Print Tax Bills and Receipts

- 1) Start at the Town of Black Wolf website under the Tax Collection & Inquiry tab (<https://townofblackwolf.com/resident-info/tax-collection-inquiry/>). You will then select the link for land records at the top of the page & highlighted below.
